Course Description

The diagnostic and sociocultural issues in the present healthcare delivery environment have resulted in an increasingly more complex professional practice. Facing challenging cases is a common dilemma encountered in the present healthcare and educational environments. In order to provide the best care possible, one needs to consider and integrate many dimensions of care, such as the child's and the family's needs and priorities, the context of care as impacted by regulatory and funding issues, and the evidence supporting the use of different interventions available through coordinated pediatric care. Furthermore, the practitioner must consider the relationships between the child's diagnosis and impairments, and their impact on the child's participation in home, school, and community. Addressing all these aspects increases the complexity of clinical practice, as the choices we make in intervention models to achieve desired outcomes will depend on the many factors surrounding health care and current pediatric service delivery (Blanche, Guiffrida, Hallway, Edwards, & Test, 2016).

Through the use of videotaped cases, hands-on experiences, and didactic presentations, this workshop will help participants optimize the outcomes of their interventions with children with developmental disabilities e.g. Autism Spectrum Disorders, Cerebral Palsy, Developmental Coordination Disorders, and Sensory Processing Disorders. Participants can register for one day or two days.

Program Objectives

UPON COMPLETION OF THE COURSE, PARTICIPANTS WILL BE ABLE TO:

1. Identify trends in health care influencing combining approaches in pediatric practice and the shift toward community rehabilitation.

- 2. Describe current evidentiary support for combining sensory integration approaches with other treatment approaches in the intervention with children with developmental disabilities.
- 3. Articulate a systematic clinical reasoning approach for identifying needs, possible treatment approaches, and outcomes measures.
- 4. Apply a clinical reasoning approach to clinical cases identify areas of deficit, and develop an intervention plan combining treatment approaches.

About the Instructors

Erna Imperatore Blanche, PhD., OTR/L, FAOTA

Graduated from the University of Chile with a degree in occupational therapy and holds a MA Degree in Special Education from Teachers College, Columbia University and a PhD in Occupational Science from the University of Southern California. Erna trained with Dr. Ayres in 1984, since then she has taught extensively around the world and has authored and coauthored multiple publications in the areas of evaluation and intervention of children with developmental disabilities, play, and occupational science. Erna is also co-owner and a co-founder of Therapy West, Inc., a treatment facility serving children with developmental disabilities in Southern California. Erna is also Professor of Clinical Practice, Chan Division of Occupational Science and Occupational Therapy, University of Southern California. In her multiple roles of professor, international lecturer, and clinician, Dr. Blanche crosses the borders between clinical practice and academic research.

Bryant Edwards, OTD, OTR/L

Bryant earned his Masters of Arts and Occupational Therapy Doctorate from the University of Southern California, and his Masters of Public Health from The Ohio State University. Having spent the entirety of his occupational therapy career working with children and adolescents, he is Board Certified in Pediatrics through the American Occupational Therapy Association. Dr. Edwards is currently the Occupational Therapy Manager at Children's Hospital Los Angeles, overseeing a staff of over 50 occupational therapists, occupational therapy assistants, and therapy aides. In addition, he has served as a consultant for school districts and therapy agencies. His volunteer leadership has included serving as the Secretary for the Occupational Therapy Association of California for 4 years, and he is currently the Vice President of the Association. For the past three years, he has been adjunct faculty at West Coast University.

Clare Giuffrida PhD, MS, OTR/L, C/NDT, FAOTA

Graduated from Columbia University with a M.S. in occupational therapy & holds a PhD in Exercise & Sport Science (Motor Control & Learning), College of Health & Human Development, The Pennsylvania State University. Clare acts as a resource liaison & practitioner for community pediatric & early intervention practices in Chicago while holding a faculty appointment in the Dept. of Physical Medicine & Rehabilitation at Rush University Medical Center, Chicago, Ill. For more than thirty years Clare engaged in occupational therapy administration, clinical management, academic & continuing education teaching, direct service delivery & research at both universities & medical centers in the United States. Her professional & scholarly contributions include national & international presentations, chapters focused on the application of motor learning/sensory integration principles to clinical practice, as well as, refereed publications within occupational therapy, rehabilitation medicine & exercise science/motor learning. In her early practice years Clare had the opportunity to train with, teach with & support the dissemination of Dr. Ayres theory and research as part of the nationally recognized faculty for sensory integration. This formative experience led to Clare's continuous efforts throughout her career to synthesize and integrate research findings with everyday occupational therapy clinical practice.
